First Semester

This college course is an in depth look at our laws, law enforcement systems, courts, emergency services personnel and corrections (probation, prisons, and parole). This course is articulated with Mt. San Antonio College for equivalency course credit for Mount San Antonio College ADJU 1 "The Administration of Justice". Students who successfully complete this course with a "B" average on all course work and final exam score of "C" are eligible to receive 3 semester units at Mount San Antonio College and are transferable to the UC and CSU College systems.

- Module 1: Crime and Its Consequnces understanding crime trends, crime reporting and media.
- Module 2: Historical Development of Police law enforcement's evolution.
- **Module 3: American Law Enforcement Today -** comparative study of jurisdictions.
- **Module 53: History and Development of Jails and Prisons** origins and evolution of incarceration, role and history of local jails, state and federal prisons.
- **Module 4: The System of American Justice -** court systems, three part system law enforcement trial courts and corrections.
- **Module 6: Constitutional Law -** Bill of Rights, concepts of due process and reasonable doubt. What is a crime/court structure-State and Federal Courts/probation and parole.
- **Module 7: The Process of American Justice -** trial by jury/arraignment/charging misdemeanors and felonies/preliminary hearing/grand jury/discovery motions/pretrial interviews/suppression hearings/plea bargains/diversion.
- **Module 8: Courtroom Testimony and Demeanor -** preparing for trial, examination of witnesses.
- Module 5: The Juvenile Justice Process juvenile court system and philosophy.
- **Module 44: Introdution to Terrorism -** what is terrorism, terrorism in the 20th Century, terrorist behavior, goals and motivations of terrorists, terrorist groups, categories of terrorist groups, future trends in terrorism.
- **Module 51: Homeland Security** Creation, Role and Mission of the Department of Homeland Security, Immigration and Customs Enforcement, Citizenship and Immigration Services, Customs and Border Protection.
- **Module 24: Powers to Arrest -** citizen's rights, booking, bail, arraignment, citizen's arrest procedure, and use of deadly force.
- Module 31: Private Protective Services history of security, modern security, regulating training.

Second Semester

This college course is an in depth look at our laws, law enforcement systems, courts, emergency services personnel and corrections (probation, prisons, and parole). This course is articulated with Mt. San Antonio College for equivalency course credit for Mount San Antonio College ADJU 3 "Concepts of Criminal Law". Students who successfully complete this course with a "B" average on all course work and final exam score of "C" are eligible to receive 3 semester units at Mount San Antonio College and are transferable to the UC and CSU College systems.

- **Module 9: General Aspects of Criminal Law -** classification of offenses elements of an offense, criminal intent, burden of proof, reasonable doubt, accessories and principals to crimes.
- **Module 10: Crimes Against the Person -** homicide, crimes of restraint, robbery, extortion, types of assaults, battery, and sex offenses.
- **Module 11: Crimes Against Property -** burglary, arson, theft, shoplifting, receiving stolen property, forgery, false identification.
- **Module 12: Crimes Against Public Order and Morality –** public disturbances, riots, unlawful assembly, disturbing the peace, resisting arrest, obscenity and pornography, indecent exposure, exhibitionism, prostitution, pandering, gambling.
- **Module 15: White Collar Crimes –** tax evasion, false advertising, mail fraud, securities fraud, monopolies and antitust crimes.
- **Module 16: The Civil Law Process -** tort law and contract law, civil trial, remedies in civil disputes, exceptions to remedies, enforcing remedies, alternatives to litigation.
- **Module 17: Tort Liability: Duties to Others -** tort law rights, intentional torts, defenses to torts, negligence, failure to act, types of liability, defamation slander and libel.
- **Module 47: Cyber Crime –** What is cyber crime cyber theft cyber vandalism cyber terrorism software theft corporate espionage theft of information.
- **Module 25: Search and Seizure -** search of person, search of the vehicle and home.
- **Module 18: Police Field Operations and Patrol -** activities of patrol division, distribution of patrol force, types of patrol, traffic control, criminal apprehension, maintenance of order and public peace.
- Module 22: Professionalism and Ethics Law Enforcement Code of Ethics.
- Module 39: Career Pathways in the Law, Public Safety, Corrections and Security Career outlook, the legal services pathway, security and public services pathway, emergency and fire management pathway, law enforcement services and corrections pathways.
